This venue is busy and actively used by persons with Protected Characteristics. It is likewise used by public services to provide services to person with Protected Characteristics.

Community Led: CG Step Forth walking group, CG Recreation club, CG Keep fit, Braveheart walking group, CG Indoor Bowling, Alcoholic Anonymous, CG share a craft, CG Chess club, Go youth group, CG Centre Art, PHAB Group, Friends of Zetland park, Bird meetings, AA Intergroup.

Private sector: Judo CG, First aid.

Public sector: FC Social Work support 6-7 sessions per week, FC ESOL Language class, NHS, Community Council.

Religious meeting – church.

A specific disabled children's programme run by FAB takes place here during school holidays: 3rd-7th April and 10th -14th April 9am -5pm daily and 3rd July - 11th August 2023 (Monday to Friday only): Meet, have lunch entertain children with disabilities. Take some children out for a time, swimming, parks, day trips but this is also used as a base. Stay in if they do not want to take part in other activities.

15 Of 35 survey respondents, expressed they have a Protected Characteristic that disadvantaged them.

Alcoholics Anonymous meet here 3 times a week along with other groups such as chess and various groups of younger people. where will they go if this unit is closed. If AA have no where to meet what happens then, at what cost would that be to the community. How about the other groups what would happen if our young people have no where to go and meet up safely what damage to them and the community then. A very large car park for plenty of organisatious to use this unit.

This building for years has hosted a weekly meeting of AA. This meeting is essential and life saving believe meZ there are now 3 AA meetings that take place there in this buildings. We have always paid our way.

"The loss of the Grangemouth Education Unit would be a great effect to our Share a Craft group and the local community. As our craft group presently has 18 Membership who have contributed to local community events for over 20 years. The Education Unit provides an accessible area and storage facilities for our Share A Craft group. Our 18 members are greatly impeded without local access to the Education Unit area as the group includes elderly with some disabilities who cannot not access outwith Grangemouth with limited public transport. The Education Unit room and table facilities for participation in promoting Craft artisan educational opportunities would prove difficult to obtain elsewhere. The Education Unit activities enables supportive fellowship encourage learning promoting opportunities retaining physical and mental activity reducing local inequalities providing a thriving community facility.

The Education Unit reduces individual members of Share A Craft Group carbon omission and provides benefits from a warm hub for in these economical challenging times.

The Education Unit Main Hall facilities provide venue for the public to attend a Coffee Mornings for Share A Craft fund raising with craft sales. Funds that provide fees for Falkirk Council and that have raised and donated funds to local and National charities.

With Grangemouth Education Unit Our Group is meeting the Falkirk Council Plan 2022 - 2027 with ""strong and healthier communities. Promoting educational attainment"". Also meets the People & Communities Towards a Fairer Falkirk 2019 - 2024 "" inclusive and fairer Falkirk". The Grangemouth Education Unit closure will result in Falkirk Council not meeting their own statement aims,".

Share a craft group has been running for 25 years. This group offers support and tackles isolation and mental health.

As an older person I use this building for company and social reasons. I use this over 3 times a week and see this as essential for me at my age now and especially after COVID restrictions kept me at home. Can library services be used in this building, other services use this i.e. social Work for access and meetings, one stop shop, health meetings, dss assistance etc.

school holiday activity programme for young people with a disability in the full of the Falkirk Council area.

Please explain 'disproportionate'. Taxpayers use this facility for a variety of reasons/needs. Each as important to them.

I run a weekly walk for vulnerable people and use this venue as a base/ tea and coffee venue. We would be out on the street literally drinking out tea and coffee and these are lonely vulnerable people.

Grangemouth Community Education Unit is located at a place where I can take my disabled child safely and quickly. There my child and her disabled peers are involved in different activities with social care providers, and they can meet and interact socially in a safe space. The location is very beneficial as the groups can go swimming together or use the café at the Grangemouth Sports complex. Being so close to Zetland park allows the children to go to the park, especially those in wheelchairs. As the funding for social care and the caregivers' availability have been receding during the last few years, and socially vulnerable groups like disabled young people/children have suffered the severe impact of the coronavirus lockdowns, I think that closing facilities which provide care and are suitable

for disabled people/children is utterly inappropriate. This will cause additional issues for families who are already struggling financially, as they will have to travel farther and spend more time and money on travel. Many of them will have issues with the increased traffic and getting to a different location (some of the disabled children suffer deeply if their routine has been changed), and this add more stress on top.

I attend the bowling and the keep fit . I am 82 and it's the only way I get to see my friends and stay active

I use the facility to keep me from getting lonely.

The club will struggle to move due to issues like equipment etc should the club be forced to move it would be expected that this will become more expensive to run we are aware that families at be unable to absorb rising costs and this will put the club which is a charity at risk of needing to close disadvantaging the community.

It would take away a vital community resource and affect scores of families who use the facilities every week

The unit provides outstanding facilities for kids and adults alike of all backgrounds, it's closure would inevitably lead to the folding of a longstanding sports club who would be forced to find a costly alternative which would definitively lead to a significant number of members deem judo unaffordable leading then away from the health and social enjoyment currently being benefited from.

I attend a group within this building. If this closes I will not be able to go. The group helps with my mental health and done so for many years.

I am a member of Deanburn Judo Club, who run adult and children classes on a Monday and Friday evening. The club offers not just judo training, but a hub for support and friendship, boosting mental health and wellbeing, boosting self confidence, and improving fitness. The club coach is a former competitor in the Commonwealth Games and wants to offer a place for all, no matter their fitness or ability, to come and practice Judo. The club trains for and attends multiple development camp and competitions all over the UK - most recently to the British Judo Council National Championships in Kettering where multiple medals were won (this has been reported in the Falkirk Herald). This would not be possible without the club having a central place to gather and train at Grangemouth Community Education Unit. The closure would not just affect myself, but the other members of the club and their families who have come together to create such a wonderful club.

A general meeting in this unit to see how the people who use it can get together and keep it for the good of all the community.

If the Council can identify and let us know where this could be held jnstead without any cost increase. I cant think of another facility as the SNP are closing them. Whilst the council want to make better use of schools many of our members would be uncomfortable especially if you have children attending there

Retaining Grangemouth Education Unit will help mitigate any specific impacts as stated above.

Shorten open hours, share use of building. Asset transfer will be difficult n could see them all close as people struggle to run and operate buildings in the long term. Don't try and close all halls and centres,.

Comments from those who do not identify as having a Protected Characteristic but have made comments on impact of closure on those who do:

We are the only Chess Club in the Falkirk Council area. We have had a significant influx of young players (from 8 to 16year old) since resuming face to face activity last year. Three of these juniors have now represented Scotland. It will be very difficult for the club to continue if the centre closes.

Loss of this facility will impact on the many groups who use the premises. There are no other properties in Grangemouth that could cater for the diverse groups that use the CEU. Closure would result in loss of a social meeting point for older members groups and a place for the younger members to learn new skills and social responsibility.

I attend an art club in the unit and have done so for many years. It is a great source of community, skills development and caring for mental health. The closure of the unit would throw this routine into disarray and have a negative impact on groups who use this facility.

We use the hall for our local judo club, closing this we will find it difficult for the club to find a new hall. This club has provided kids in a deprived area for 30 years somewhere they can have fun, gain skills, increase fitness levels and make friends and recently one member gain a gold British medal. The costs at the moment for the kids covers license fees for BJC, new premises means increasing costs for parents already struggling in the cost of living crisis. Without this kids will be roaming streets on Monday and Friday nights, may increase anti social complaints leaving policing with a higher workload.

There are many other groups who run out of this unit. Has this been looked at or even thought about. This will impact many peoples mental and physical health.

The unit has been running on a shoestring for many years now with problems caused by poor maintenance and neglect. The CEU Committee have been providing financial assistance over the years to purchase many items for the benefit of the groups without recourse to funding from the Council.
