Monthly usage sample - Hall Management Committee did not provide this information. The Volume and nature of comments note a busy activity schedule and that this building has a large hall (100+) and a stage.

Slimming World, Games, weekend private parties, baby activities (business).

Of 28 survey respondents, 14 expressed they have a Protected Characteristic that disadvantaged them.

Comments from those who identify as having a Protected Characteristic:

This venue is where I run my Slimming World groups, supporting members of the local community to live healthier and more active lifestyles and positively impacting the health of Grangemouth and surrounding areas. To close this venue would not only have a significant impact on my business and income, but also leave over 100 members a week (and growing) without the support of our group. There aren't any alternative venues to use and it is a necessary lifeline for so many people.

This hall provides me with my Slimming World class which is invaluable both to me and the approx other 100 users for health and well-being

His hall is used for over 100 people in the community on Saturday mornings. It's used to help people lose weight and benefit health wise. I couldn't go further away due to mobility issues. I have lost three stones by using this. I couldn't do it on my own, I would probably put weight back on. As well as losing weight I have met lots of new friends, please don't close this facility. I've been using these facilities for more than fifty years.

My health has greatly improved by attending group in this facility, physically and mentally. My disability impairs me less since joining and the group is essential for helping me maintain the healthy lifestyle I need to maintain this benefit. There are so few suitable venues already that this will be a major loss if the venue closes. Another solution needs to be found or you risk reducing quality of life and increasing health and disability issues in the community.

Can't afford to travel to further away venues and it's too much strain on my health

I benefit greatly from attending a Slimming World group on a Saturday morning. Losing weight has improves my mental and physical health. It has enabled me to

meet new friends too. I also attend a Mind Body and Soul yoga group on a Wednesday evening. This again, has improved my mental and physical health and helped reduce age related joint problems. I have also met new friends through this.

I use this facility every week.

Attend a slimming world group, this has helped me lose weight, improve my health (physical and mental).

This is where my weekly group meets. The closure would adversely affect my mental and physical health.

This hall runs a Slimming World class on a Saturday morning for which there are more than 100 people attending. You close this down and where would we go?! There's nowhere left to hold group meeting. This would have a detrimental effect on so many people's diet, health and we'll being. Not to mention mental health state. This is my and many other people's only connection to the outside world. Please reconsider.

I attend this centre every Saturday morning and it would have a detrimental impact on my health if it closed.

Between my husband and I we attend 3 groups in this hall, and they have been life changing for us.

Don't close it. This venue is perfect for both activities. The parking is good. It feels safe, even at night-time and there are toilet and kitchen facilities. If you close it, you would have to offer the same facilities elsewhere.

Ensure suitable alternative venue is available.

Don't close it!

None. This hall is very well used and it makes no sense to close it.

Comments from those who do not identify as having a Protected Characteristic but have made comments on impact of closure on those who do:

It's beneficial for my son but also for me as it lets me meet other mum's for advice and support.

If this venue was to close it would have a substantial effect on our family income. We have a number of customers who greatly benefit from the class to help manage their physical and mental health.

Find the yoga classes help with the stress of working full time and being my mum's carer.
